USEF rules are in effect upon arrival at the show grounds, including Saturday. They are available on the USEF website. If you have any questions, contact Show Management or the Technical Delegate, Lorre McGee. There are two bridle numbers per horse for this show. One is for the halter. USEF Rules require that numbers be displayed whenever horses are out of their stalls. Please check in and obtain numbers prior to working horses.

The Dale Creek gate does not open until 6:00a.m. Plan your arrival accordingly.

Competitors who ride early Sunday are encouraged to check in at Dale Creek during Show Office hours from 1:00 – 5:00 pm on Saturday, Feb 18th. We will provide additional staff at check-in Sunday, but please allow enough time at the Show Office.
